ENGLISH DEBATE COMPETITION GUIDELINES

THIS IS OUR CARE (TOC) 2018

A. GENERAL REQUIREMENTS

In this Regulation, what is meant by:

1. This Is Our Care (TOC) 2018 is a competition in the field of national science held by students of the Faculty of Nursing, Universitas Padjadjaran (FKep Unpad).
2. The English Debate Competition is part of TOC 2018 series.
3. Participants shall be teams consisting of 3 (three) students of universities throughout Indonesia who have registered themselves, and recorded as participants by the committee.
4. The committee is a student of the Nursing Faculty of Universitas Padjadjaran who acts as the organizer of the race event which is a unity with the committee of This Is Our Care (TOC) 2018.
5. Technical Meeting is a meeting organized by the Committee before the race begins which aims to explain the rules of the race, appraisal, implementation technique, race system and team draw.
6. The motion is a topic that has been announced by the committee to be debated by the participants in the race.
7. The impromptu motion is a motion which is not previously announced, this motion will be given to the committee shortly before the race to be debated by the participants.
8. The Affirmative Team or The Government Team is a team that agrees with the motion and is responsible to provide arguments to support the motion.
9. The Negative Team or The Opposition Team is a team that disagrees with the motion and is responsible to argue against the motion.

10. The speaker is one of the participants who is presenting the argument.
11. Chairperson is one of the committees who is served to facilitate the course of the debate.
12. Timekeeper is one of the committees who is in charge to oversee the time of the race.
13. Point of Information (POI) is a refutation or question given by the opposing team upon approval by the speaker according to the applicable provisions.
14. The Jury is a party who has the authority to provide an assessment in accordance with the criteria established in this race.
15. Assessment is the result of the jury's observation of the debate that occurs based on the criteria set by the committee, in the form of a score given before the race.
16. Margin is the difference in value between two competing teams.
17. Score Team is the accumulated score of each speaker in one round.
18. The preparation of the argument is the time given to the participants before the debate begins to prepare the material and arguments to be debated.
19. Supporters shall be parties other than participants and committees brought by the participants pursuant to the approval of the Committee

B. TERMS AND CONDITIONS OF PARTICIPANTS

1. Participants are active nursing students of Strata-1 (S1) or equivalent who are still enrolled in the universities, both public and private, in Indonesia. Debate participant is team.
2. In one university both State and Private could send 2 (two) teams in maximum.
3. Participants must meet the administrative requirements.

Each team must include the scanned documents of each members, in the form of Student Identity Card (KTM), 3x4 photographs, and proof of payment.

4. Participants may not be assigned to different teams of the same university.
5. Participant who has paid the registration fee, but later cancelling their participation, would not get their fee refunded.
6. Teams that do not meet the requirements of point 1 (one) cannot participate in the race.

C. REGISTRATION

1. Participants must register their team by completing the registration form which could be downloaded from: <http://bit.ly/BerkasEnglishDebateTOC18>
2. Every participant is required to pay the registration fee in the amount of Rp150.000,00 for the first period registration and Rp180.000,00 for the second period. The registration fee should be transferred to the committee as detailed below:

D. STAGES OF THE COMPETITION

The competition consists of 3 (three) round of match:

1. Preliminary Round;
2. Semi Final Round;
3. Final Round.

PRELIMINARY ROUND

1. The preliminary round consists of 1 (one) debate game.
2. The committee will conduct a draw against the team to determine the opponents of each team.
3. Ten teams with the highest score in this round can proceed to the semi-finals.
4. The highest order of value is determined by the score.
5. If there is a same score, the order of value is determined by margin.
6. If there is a similarity of score and margin, the order of values is determined based on the opinion of the jury.

SEMIFINAL ROUND

1. Ten teams that qualify from the preliminary round will return to compete in the semifinals.
2. The semifinal round uses a system of accumulated scores from the preliminary round.
3. Four teams with the highest score in the semi-final will continue to the final round.

FINAL ROUND

1. Four teams that qualify from the semifinals will compete in the final round.
2. The final round uses the system of the accumulated score.

E. SYSTEM OF THE COMPETITION

1. This competition refers to the Asian Parliamentary Debate System.



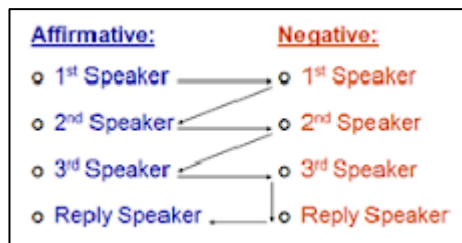

2. In every game, there will be 2 (two) teams which will be divided into Affirmative Teams (Government Team) and Negative Teams (Opposition Team).
3. The division of Affirmative Teams and Negative Teams will be determined before the preparation of the argument.
4. Each Affirmative Teams and Negative Teams have three speakers, consist of the first speaker, the second speaker, and the third speaker.
5. The first speakers or the second speaker from both Affirmative Teams and Negative Teams will also act as the reply speaker.
6. The third speaker from both the Affirmative Teams and Negative Teams is not allowed to be the reply speakers.
7. All members of the Affirmative Teams and Negative Teams are allowed to interrupt or deliver Point of Information (POI) after the first minute of the speakers' speech, exclude the first speaker's speech.
8. The flow of the match will be explained through the chart below:



F. DEBATE MECHANISM

1. Each team is given fifteen (15) minutes to do the preparation afterwards the motions and houses' division are announced by the committee.
2. The period time each speaker has to deliver the arguments is as follows:
 - a. The first, second and third speakers are given 5 (five) minutes with the following conditions:
 - (i) In the first minute, the timekeeper will knock 1 (one) time to indicate that POI is allowed
 - (ii) In the fourth minute, the timekeeper will knock 2 (two) times to indicate that POI is not allowed.

- (iii) In the fifth minute, the timekeeper will give persistent taps until the speaker completes delivering the argument to indicate that the speaker has exceeded the given time.
- b. Reply speakers are given 3 (three) minutes, subject to the following conditions:
 - (i) In the first minute, the timekeeper will knock 1 (one) time
 - (ii) In the second minute, the timekeeper will knock (two) times to indicate the speaker there is only 1 (one) minute remaining to deliver the argument.
 - (iii) In the third minute, the timekeeper will give persistent taps until the speaker completes to deliver the argument, to indicate that the speaker has exceeded the given time.
- c. If the speaker still exposes his argument while the given time has expired, then the argument will not be judged by the jury.
- d. If the first, second, and third speakers spend less than 4 (four) minutes over 5 (five) minutes, then the methods aspects will be reduced.

G. POINT OF INFORMATION

1. Participants are permitted to deliver interruptions or questions between the first and the fourth minute when the second or third speaker is presenting the argument.
2. POI as referred to point number (1) is not allowed when the first and the reply speakers are delivering the argument.
3. The maximum time to deliver POI is a maximum of 15 (fifteen) seconds.
4. POI that exceeds the time limit of 15 (fifteen) seconds will be terminated by the chairperson.
5. Request for POI shall be done by raising the hand.
6. POIs are made within the speaker's permission.
7. After being granted by the speaker as referred to point (6), POI is performed while standing.

H. JUDGING

1. The jury shall consist of 1 (one) person in the preliminary round.

2. For the semifinal and final, the jury will be consisted of 3 (three) people.
3. All races will be judged and decided by the jury.
4. The jury's verdict is final and cannot be contested.
5. Judging will be done by considering 3 (three) aspects: materials (matter), attitudes (manner), and methods. Each composition in sequence is 40 points, 40 points, and 20 points.

I. MOTION

1. The motions will be given on September 20th, 2018 through TOC's website and social medias.
2. The motions in the preliminary round will be taken from the list of motions shared through TOC's website and social media.
3. The semifinal and final round will use the impromptu motions.
4. The specified motion is final and cannot be contested.

J. TECHNICAL PROVISIONS

GENERAL

1. Each participant is required to wear a polite and neat outfit during the race.
2. The whole game is done by using good and correct English.
3. Every participant must attend on time.
4. Every participant is prohibited to discuss any motions of any kind with any other parties outside of their team-mates during the preparation of the arguments.
5. Each participant must notify the speaker's order in exposing the argument to the panel during case building in the discussion room.
6. Participants are prohibited from using any electronic devices connected to the internet to reassurance any information or arguments during the preparation and the race.

PARTICIPANT'S CODE OF CONDUCT DURING THE MATCH

1. Every participant is prohibited from personally attacking other participants during the game.
2. Every participant is prohibited to use abusive, indecent and / or offensive language.
3. Each participant is prohibited from taking any action that may interfere with the concentration of other participants during the game.
4. Speaker team members can signal to speakers who are presenting the argument as long as the signal does not interfere the course of the debate.
5. Speakers are prohibited to communicate verbally with their teammates while delivering their arguments.
6. During the match, participants who are not speakers are allowed to do discussions as long as they do not disrupt the course of the debate.

Violations against the above provisions result in a reduction of scores

K. SUPPORTERS

1. The number of supporters who are allowed to watch the game are maximally 3 (three) people.
2. Supporters are prohibited to disturb the match.
3. Supporters are prohibited to enter the room as long as the speaker is exposing his argument.

Supporters who violate the provisions of paragraphs (2) and (3) will be warned twice in maximum, if warnings are ignored, the supporters will be expelled.
